#### SOLICITATION INFORMATION

- Permitted Hours: Monday-Friday: 10:00 am to 7:00 pm; Saturday: 10:00 am to 6:00 pm
- <u>Permit Display:</u> Every person shall display the permit at all times and exhibit the permit when requested to do so by any prospective customer or police department employee.
- <u>Transfer Prohibited:</u> Permit shall not be transferred to another person:
- <u>Entry</u>: No person, whether licensed or unlicensed, while conducting the business of a canvasser, peddler, or solicitor, to enter upon any residential premises in the village where the owner, occupant, or person legally in charge of the premises has posted, at the entry to the premises, or at the entry to the principal building on the premises, a sign bearing the words "No Peddlers," "No Solicitors," "No Canvasser", "Peddlers, Solicitors or Canvasser Prohibited" or similar words.
- <u>Penalty:</u> Any person or organization engaged in solicitation who commits an offense shall be fined not less than Two Hundred Fifty Dollars (\$250.00) nor more than Seven Hundred Fifty Dollars (\$750.00) for each offense. In addition to the monetary penalties above listed, the violator may be prosecuted for violation of various trespass offenses under applicable law.

#### APPLICATION REQUIREMENTS

- Application must be submitted in person at:
  - o Inverness Police Department, 1415 Baldwin Rd, Inverness, IL 60074 (during regular business hours)
- All applicants must provide evidence that they are authorized to solicit for the organization represented. Please attach the appropriate documentation to verify this authority.
- Fee payment. (See above)
- At the time of application, all applicants must be fingerprinted at the Inverness Police Department. The applicant will have a background check conducted by the Inverness Police Department.
- All applicants must submit two passport-sized photographs of the applicant taken within 60 days immediately prior to the date of filing of the application. The photographs shall show the head and shoulders of the applicant in a clear and distinguishing manner.
